No. GYC-10-2017/PRV/102007/3578/A :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Technical Assistant, Class III, in the Directorate of Archaeology and Museums Recruitment Rules, 2011, namely :-

1. These rules may be called the Technical Assistant, Class III, in the Directorate of Archaeology and Museums Recruitment (Amendment) Rules, 2017.

2. In the Technical Assistant, Class III, in the Directorate of Archaeology and Museums Recruitment Rules, 2011, (hereinafter referred to as "the said rules"), in rule 3,

(i) for clause (a), the following shall be substituted, namely:-

"(a) not be more than 37 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967."

(ii) in sub clause (b) in sub clause (i), in para (c), the words "or possess an equivalent qualification recognised as such by the Government;" shall be deleted;

(iii) in clause (b), existing two proviso after sub-clause(iii) shall be deleted.

3. In the said rules, for rule 4 the following rule shall be substituted, namely: -

"4. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of the candidate appointed by direct selection."

4. In the said rules, rules 5 and 6 shall be deleted.
