No. GYC/11/2019-PRV/102008/3580/A : In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Superintending Archaeologist, Class II in the General State Service, under the Directorate of Archaeology and Museum, Gujarat State, namely :-

1. These rules may be called the Superintending Archaeologist, Class II, under the Directorate of Archaeology and Museum, Recruitment Rules, 2019.
2. Appointment to the post of Superintending Archaeologist, Class II, in the General State Service, under the Directorate of Archaeology and Museum, Gujarat State shall be made either, -
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who, -
 - (i) have worked for not less than seven years in the cadre of Technical Assistant, Class III, in the subordinate service of the Directorate of Archaeology and Museum, Gujarat State and

(ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub- clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub- clause (i) above; or

(b) by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall, -

(A) not be more than 39 years of age :

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

Provided further that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and

Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned;

(B) possess, –

(i) a post-graduate degree in Archaeology obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as a Universities under section 3 of the University Grants Commission Act, 1956; or

(ii) (a) a post-graduate degree in any one of the following subjects, namely:-

History or Geology or Zoology or Anthropology or Ethnology or Sanskrit or Arabic or Ancient Indian History, Culture and Archaeology or Indian Culture (with Art and Iconography, Numismatics and Paleography/epigraphy) obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as a Universities under section 3 of the University Grants Commission Act, 1956; and

(b) a post graduate Diploma in Archaeology;

obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as a

Universities under section 3 of the University Grants Commission Act, 1956; and

(C)(i) have about one year experience of organization on the post not below the rank of Technical Assistant, Class III in the subordinate service of the Directorate of Archaeology and Museum, Gujarat State; or

(ii) have about one year combined or separate experience in the field of Archaeological work such as Exploration or Excavation in organization of an Archaeology in the public sector or private sector on the post which can be considered equivalent to the post not below the rank of Technical Assistant, Class III in the subordinate service of the Directorate of Archaeology and Museum, Gujarat State; or

(iii) have one year combined or separate experience in Archaeological field work such as Exploration or Excavation or Documentation of Antiquities or heritage monuments of Archaeological sites on the post which can be considered equivalent to the post not below the rank of Technical Assistant, Class III, in subordinate service of the Directorate of Archaeology and Museum, Gujarat State;

(D) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(E) possess adequate knowledge of Gujarati or Hindi or both.

4. The candidate appointed by direct selection shall be on probation for a period of two years.
5. The candidate appointed by direct selection shall, during his probation period, be required to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's Pre-service Training and Examination Rule, 1970.
6. The candidate appointed by direct selection shall, during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
7. The candidate appointed by direct selection shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
8. The candidate appointed either by direct selection or by promotion shall be required to undergo such training and pass such examination as may be prescribed by the Government.
9. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
