CONSTITUTION OF INDIA.

No.GYC/1/2010/ PRV/102009/1150/A .- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Building Survey Assistant, Class - III in the subordinate service of the Director of Archaeology, namely:-

1. These rules may be called the **Building Survey Assistant, Class - III, Recruitment Rules, 2010.**
2. Appointment to the post of Building Survey Assistant, Class III, in the subordinate service of the Directorate of Archaeology shall be made by direct, selection.
3. To be eligible for appointment by direct selection to the post of mentioned in rule 2, a candidate shall -
 - (a) not be more than 28 years of age: and
 - (b) possess -
 - (i) A Second Class bachelor's degree in Arts with the ancient Indian culture or History as main subject obtained from any of the Universities or institute established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared as deemed University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognized by the Government;
 - Or
 - (ii) Diploma in Architecture Assistantship of a recognized Institution;
 - (iii) the basic knowledge of computer application as prescribed In the Gujarat Civil Service Classification and Recruitment (General) Rules, 1967,
 - (c) possess adequate knowledge of Gujarati and / or Hindi:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules 1967.
4. The candidate appointed by direct selection shall be on probation for a period of one year.
5. The selected candidate shall during his probation period be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
6. The selected candidate shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government from time to time.
7. The selected candidate shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government from time to time.
