CONSTITUTION OF INDIA.

No. GYC/11/GTL-102008-215/1950-F:--In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of **Librarian, (Class-I)**, in Gujarat Library Service, namely:-

1. These rules may be called the **Librarian (Class-I) Recruitment Rules, 2013**.
2. Appointment to the post of **Librarian (Class-I)** in the Gujarat Library Service, shall be made either-
 - (a) by promotion of a person, of proved merit and efficiency, from amongst persons, who,
 - (i) have worked for not less than eight years in the cadre of **Assistant Director of Libraries (Class-II)**; in the Gujarat Library Service,
 - (ii) possess a Bachelor's degree of any of the universities incorporated or established by or under the Central or State Act in India or any other Educational Institution recognized as such or declared to be a deemed University under Section 3 of the University Grants Commission Act, 1956, or possess an equivalent qualification recognized by the Government, and
 - (iii) possess a post graduate degree in Library and information Science or a second class degree in Library and information science of any of the Universities incorporated or established by or under the central or state Act in India or any other educational institution recognized as such or declared to be a deemed Universities under section-3 of the University Grants Commission Act, 1956, or possess an equivalent qualification recognized by the Government.
 - (iv) have passed the qualifying examination for Computer Knowledge in accordance with the provision of the Gujarat Civil Services Computer Competency Training and Examination Rules 2006,

Provided that where the appointing authority is satisfied that a person having the experience specified in clause (a) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in clause (a) above; or

- (b) by direct selection;
3. To be eligible for appointment by direct selection to the post mentioned in rule-2, a candidate shall-
 - (a) not be more than 38 years of age;

Provided that the upper age limit may be relaxed in favor of a candidate who is already in the service of Government of Gujarat in accordance with the provision of the Gujarat Civil Services Classification and recruitment (General) Rules 1967;

- (b) Possess-
 - (i) a second class degree of any of the Universities established or incorporated by or under the Central or State Act in India; or any other Educational Institution recognized as such or declared to be a deemed University under Section 3 of the University Grants Commission Act, 1956, or possess an equivalent qualification recognized as such by the Government and
 - (ii) a Post Graduate degree in Library and information Science obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other Educational Institution recognized as such or declared to be a deemed

University under Section-3 of the University Grants Commission Act, 1956, or possess an equivalent qualification recognized as such by the Government.

- (c) Possess the basic Knowledge of Computer Application as prescribed in the Gujarat Civil Services Classification and recruitment (General) Rules 1967,
- (d) (i) have about six years experience on the post not below the rank of District Librarian, Class-III in Government, or,
- (ii) have about six years experience of Inspection and/or Administration of Libraries in Government under taking Board or Corporation or in Local Bodies on the post Which can be considered equivalent to the post not below the rank of District Librarian, Class-III in Government, or,
- (iii) have about six years experience of Inspection and/or Administration of Libraries of or registered trust or public sector or private sector organization on the post which can be considered equivalent to the post not below the rank of District Librarian, Class-III, in the Government.
- (e) Possess adequate knowledge of Gujarati or Hindi or both
4. The candidate appointed by direct selection shall be on probation for a period of two years.
5. The candidate appointed by direct selection shall, during his probation period required to undergo pre-service training and pass the post training examination in accordance with the provision of the Gazetted officer's pre-service Training and Examination Rules, 1970.
6. The candidate appointed by direct selection shall during his probation period required to pass the qualifying examination for Computer Knowledge in accordance with the provision of the Gujarat Civil Services Computer Competency Training and Examination Rules 2006.
7. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
8. The candidate appointed either by promotion or by direct selection shall require to undergo such training and pass such examination as may be prescribed by the Government from time to time.
9. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by Government.
