CONSTITUTION OF INDIA.

No.GYC/8/2010/PRV/102008/1420/A .— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Sub-Overseer, Class III, in the Subordinate Service of the Directorate of Archaeology, namely:-

1. These rules may be called the **Sub-Overseer** (Department of Archaeology), Class III, Recruitment Rules, 2010.
2. Appointment to the post of Sub-Overseer, Class III, in the Subordinate Service of the Directorate of Archaeology shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall -
 - (a) not be more than 26 years of age; and
 - (b) possess-
 - (i) a Diploma in Civil Engineering with Second Class of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational Institution recognized as such or deemed to be a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized as such by the Government;
 - (ii) the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
 - (c) (i) have about separate or combined one year experience in conservation or preservation or restoration of the monuments; or
 - (ii) have about three years experience of construction work in Government or Local Bodies or Government undertaking Board or Corporation or Private or Public Sector Organization;
 - (d) possess adequate knowledge of Gujarati or Hindi or both:
Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
4. The selected candidate shall be on probation for a period of one year.
5. The selected candidate shall require, during his probation period, to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
6. The selected candidate shall require to pass an examination in Hindi or Gujarat or both in accordance with the rules prescribed by the Government.

7. The selected candidate shall have to undergo such training and to pass such examination as may be prescribed by the Government.
8. The selected candidate shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

CONSTITUTION OF INDIA.

No. GYC/14/102015/PRV/102008/1420/A :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the **Sub-Overseer** (Department of Archaeology), Class III, Recruitment Rules, 2010, namely :-

1. These rules may be called the Sub-Overseer (Department of Archaeology), Class III, Recruitment (Amendment) Rules, 2015.
2. In the Sub-Overseer (Department of Archaeology), Class III, Recruitment Rules, 2010, (hereinafter referred to as "the said rules"), in the preamble, for the words "Directorate of Archaeology", the words "Directorate of Archaeology and Museums", shall be substituted.
3. In the said rules, in rule 1, for the brackets and words " Department of Archaeology", the brackets and words " Directorate of Archaeology and Museums" shall be substituted.
4. In the said rules, in rule 2, for the words "Directorate of Archaeology", the words "Directorate of Archaeology and Museums" shall be substituted.
5. In the said rules, in rule 3, in clause (a), for the figure and word "26 years", the figure and word "29 years" shall be substituted.
